It is stated that assessment report (May, 2011) on the standard of examination and other teaching facilities available at Vydehi Institute of Medical and Research Centre, Bangalore for purpose of recognition of MD(Anatomy) qualification granted by Rajiv Gandhi University of Health Sciences, Bangalore was considered by the Board of Governors and it was decided as under:-

The Board of Governors considered the assessment report (May, 2011) and the recommendation of the postgraduate committee and decided that MD(Anatomy) qualification granted by Rajiv Gandhi University of Health Sciences, Bangalore in respect of students being trained at Vydehi Institute of Medical and Research Centre, Bangalore be recognized and included in the 1st Schedule to the I.M.C. - 6.4 The recognition so granted to a Post Graduate Course shall be for a maximum period of 5 years, upon which it shall have to be renewed.
- 6.6 Failure to seek timely renewal of recognition as required in sub-clause-4 shall invariably result in stoppage of admissions to the concerned Post Graduate Course.
