

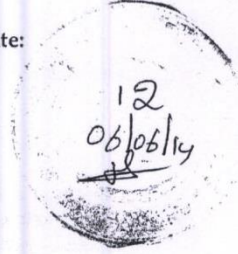

I am to state that the General Body of this council at its meeting held on 28/03/2014 considered the Council assessor report (May, 2013) on the standard of examination and other teaching facilities available at Vydehi Institute Of Medical Sciences & Research Centre, Bangalore for purpose of Recognition of MS(Orthopaedics) qualification against increased intake from 03(Three) to 04(Four) seats granted by Rajiv Gandhi University of Health Sciences, Bangalore.

The Council approved the following recommendations of the Postgraduate Committee, which I am directed to convey herewith for your information and necessary action:-

"The Postgraduate Committee considered the assessment report (May, 2013) and decided to recommend that MS(Orthopaedics) qualification against increased intake from 03(Three) to 04(Four) seats granted by Rajiv Gandhi University of Health Sciences, Bangalore in respect of students being trained at Vydehi Institute Of Medical Sciences & Research Centre, Bangalore be recognized and included in the 1st Schedule to the I.M.C. Act, 1956.

The Council further approved the following recommendation of the Postgraduate Committee as amended:

"The Postgraduate Committee further decided that the attention of the institute be drawn to Sections 6 (4), 6 (5) & 6 (6) of Postgraduate Medical Education Regulations, 2000 as amended by amendment notification "Postgraduate Medical Education (Amendment) Regulations, 2009 Part-II" dt. 21/07/2009 and act appropriately at appropriate time which read as under:

6. ...

(4) The recognition so granted to a Post Graduate Course shall be for a maximum period of 5 years, upon which it shall have to be renewed.

(5) The procedure for Renewal of recognition shall be same as applicable for the Award of recognition.







2. After careful consideration of the scheme and taking into consideration the recommendations of Medical Council of India in this regard, this Ministry has come to a conclusion that a letter may be issued for obtaining certain essential documents required for issuance of Letter of Permission (LoP) for starting/increase of seats in the following postgraduate course(s) with intake of students mentioned against each course from the academic session 2017-18 at your college under Section 10 (A) of IMC Act:

3. Therefore it is requested to furnish the following documents/undertaking/acceptance of conditions to the Ministry:-

- i) The applicant should provide all infrastructural facilities in terms of teaching and non-teaching staff, buildings. Equipment and hospital facilities as per Medical Council of India norms.
- ii) No student should be admitted in the above course till the formal permission of the Central Govt. is granted.
- iii) The Private Medical College should provide **Bank Guarantee of required amount in favour of Medical Council of India, New Delhi valid for three years from a nationalized/scheduled Bank as per MCI's norms against increase in seats in above said course.** However, medical colleges/institutions governed by the State Govt. are required to furnish only an undertaking to provide funds in their plan budget till the facilities are fully provided as per time bound programme indicated by them.
- iv) The Govt. Medical College(s) (except those colleges located in Andhra Pradesh, Telangana & J&K) should give an undertaking authorising Medical Counselling Committee (MCC), Directorate General of Health Services, Ministry of Health & Family Welfare, Government of India to include 50% of PG (Medical) seats in All India Quota PG seats for the year 2017-18.

4. Action to grant formal permission of the Central Govt. for starting/increase of seats in the said course at your college will be initiated on receipt of a compliance report fulfilling the conditions enumerated in paragraph 3 above. **The Bank Guarantee/undertaking may therefore be sent immediately to enable the Govt. to issue Letter of Permission for the year 2017-18. It may be noted that 28.2.2017 is the last date for issue of LOP.**
