"The Postgraduate Medical Education Committee considered the Assessment Report (July, 2014) and decided to recommend that DM(Cardiology) qualification granted by Rajiv Gandhi University of Health Sciences, Bangalore in respect of students being trained at Vydehi Institute Of Medical Sciences & Research Centre, Bangalore be recognized for 1 (One) seat and included in the 1st Schedule to the I.M.C. 
