

2. It is to inform you that your institution is fully responsible to fulfil and maintain norms including the infrastructure both physical and human resources, teaching faculty, clinical material and stipend to PG students similar to PG students of government colleges in the state etc. throughout the academic year, as stipulated in regulation of National Medical Commission (NMC).

3. In case of false/wrong declaration or fabricated documents have been used for procuring permissions of MARB and any misconduct is
