The compliance report should be submitted to the PGMEB of NMC along with the requisite fee of Rs.1,18,000/- (which includes 18% of GST) by RTGS/ NEFT (the details of fee i.e. UTR No. and date should be provided along with the compliance being submitted by you). In case, no compliance

is received within the stipulated period or compliance is found unsatisfactory, it will result in stoppage of admission in terms of Regulation 6(2) and 6(3) of PGMER-2000.

Information in any other format will not be accepted.
