



With reference to above, I am directed to inform that the inspection report (June, 2010) on the standard of examination and other teaching facilities available at Vydehi Institute of Medical Sciences & Research, Bangalore carried out for purpose of recognition of M.D.(Pathology) qualification was considered by the Board of Governors and it was decided as under:-

"The Board of Governors considered the inspection report (June, 2010) and decided that M.D.(Pathology) qualification granted by Rajiv Gandhi University of Health Sciences, Bangalore in respect of students being trained at Vydehi Institute of Medical Sciences & Research, Bangalore be recognized and included in the 1st Schedule to the I.M.C. Act, 1956 restricting the number of admissions to 2(two) students per year."

The Board of Governors further decided that the attention of the institute be drawn to Clauses 6.4 and 6.6 of the Postgraduate Medical Education (Amendment) Regulations, 2000, Part-II, dated 21st July, 2009 and act accordingly at appropriate time, which reads as under:-

6.4 The recognition so granted to a Post Graduate Course shall be for a maximum period of 5 years, upon which it shall have to be renewed.

6.6 Failure to seek timely renewal of recognition as required in sub-clause-4 shall invariably result in stoppage of admissions to the concerned Post Graduate Course.

You are therefore requested to notify the above qualification at the earliest.

The Council approved the following recommendations of the Postgraduate Committee, which I am directed to convey herewith for your information and necessary action:-

"The Postgraduate Medical Education Committee considered the Assessment Report (June, 2014) and decided to recommend that MD(Pathology) qualification against increased intake from 02 to 04 seats granted by Rajiv Gandhi University of Health Sciences, Bangalore in respect of students being trained at Vydehi Institute Of Medical Sciences & Research Centre, Bangalore be recognized and included in the 1st Schedule to the I.M.C. Act, 1956.

The Postgraduate Medical Education Committee further decided that the recognition so granted shall be for a maximum period of 5 years from the date of Notification upon which the Institute shall have to apply for renewal of recognition. Failure to seek timely renewal of recognition as required shall invariably result in stoppage of admission to the postgraduate course."
